Further, that there may be other risks not known or not reasonably foreseeable at this time.
 3. Assume all the foregoing risks and accept responsibility for the damages following such injury, permanent disability or death.
 4. Release, waive, discharge and covenant not to sue The Central Wisconsin Water Ski Show Team, its affiliated clubs, their respective administrators, directors, agents, coaches, board members, and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releases", from any demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by negligence of the releases or otherwise.
- All memberships will expire on December 31, 2018.
 - All members are required to be affiliated with USA Water Ski (USA-WS), and register for insurance purposes as with an active or grassroots USA-WS membership.

Parent/Adult Code of Conduct

(Adapted from the US Figure Skiing Parent's Code of Conduct) Rev. Jan 2015

Codes of Conduct give everyone a guide as to what is expected of us if we are part of an organization, participating in a sport, or as spectators.

By signing below, I hereby agree that:

1. I will encourage **good sportsmanship** by demonstrating positive support for all skiers and volunteers at every practice and show.
2. I will encourage my child and other skiers to ski in a **safe and respectful environment**.
3. I will **inform those in authority** of any physical disability or ailment that may affect the safety of my child or the safety of others.
4. I will teach my child that doing one's best is important; however, I will **place the emotional and physical well-being of my child ahead of my personal desires** for his/her achievements.
5. I will **never ridicule** or yell at my child, other participants or volunteers for making a mistake.
6. I will do my best to make skiing fun, and I will remember that my child participates in **skiing for his/her own enjoyment and satisfaction** – not mine.
7. I will ask my child to treat all skiers, volunteers, board members, and audience members with **respect**, regardless of race, creed, color, sexual orientation, or ability.
8. I will **applaud a good effort**, emphasizing the positive accomplishments & learning from the mistakes.
9. I will teach my child to **resolve conflicts** without resorting to hostility or violence.
10. I will be a **positive role model** for my child and other skiers.
11. I will demand a skiing environment for my child that is **free of drug or alcohol abuse**, and agree that I will not use or provide to a third party any drug prescribed by applicable federal, state, or municipal law.
12. I will **not provide alcohol to, or condone the use of alcohol by, minors or abuse** alcohol in the presence of skiers.
13. I will respect those in authority and will **refrain from coaching my child or other skiers** during practices because it may conflict with the show director's plan or strategies.
14. I will recognize the **importance of volunteering and show appreciation for other volunteers** and club officials.
15. I will **respect the volunteer Board of Directors and refrain from criticizing their actions**. However, I understand that I can address the Board of Directors directly via e-mail, telephone, or at a board meeting.
16. I will not compare my child's skill level or number of show acts to other skiers on the team.

EXPECTATIONS OF ALL MEMBERS

- * Display good sportsmanship and respect for all people at all times.
- * Be a positive role model.
- * Avoid foul language and negativity.
- * Display caution and care for all equipment owned by the Team, myself and others.
- * Demonstrate and promote safe practices and responsible behavior on and off the water.
- * Volunteer and participate in fundraising, promotional activities and other team activities.
- * Skiers will participate in all team practices, shows and tournaments to the best of their ability.

RULES

The following rules may or may not be part of the official team bylaws but have been approved by the board.

1. Members shall follow all Federal, State and local laws, rules, ordinances, and policies, and assume consequences by the authorities and/or the Team for non-compliance.
2. No team member shall be present or participate in team activities* under the influence of any mind altering substance including alcohol. Under the influence is defined as any detectable level of the substance, or if participation would be a risk of danger to self or others. A variance by the Board may be made in special circumstances.
3. No member shall use or encourage use of any amount of alcohol, drug or controlled substance to any member under legal age, regardless of whether it is a Team activity* or not.
4. Smoking will not be permitted by anyone under legal age, or by anyone in boats or skier areas.
5. Unauthorized or improper use of equipment (Team or individuals) will not be tolerated. Team equipment may not be used by an individual outside of an approved scheduled team practice or show unless properly approved and signed out.
6. Non-members shall never be allowed in boats, nor allowed in equipment storage or staging areas during ski functions.
7. Those without active USA Ski insurance shall not actively participate in shows, practices, or be in Team boats.
8. Team boats may be used only during an approved scheduled practice, show, or team activity*.
9. Proper floatation shall be used for all designated water ski acts, as per Safety Coordinator instruction and/or current law.
10. Reckless conduct and behavior shall result in removal of member privileges (i.e. boat driving, skiing, dock conduct, etc.).
11. Team members will report for all team activities* on time, as directed, unless proper advance arrangements have been made to Show Director or designated member in advance.
12. Any unsportsmanlike conduct by team members and/or behavior causing a negative impact on the team may be penalized at the discretion of the Board.
13. Notify the show director at least three days in advance if you will be absent from a show. Special circumstances will be taken into consideration.
14. Each individual will be expected to participate in fundraising and other volunteer activities.
15. The Show Director has final say of show line up. Do not change the show board without authorization from the Show Director(s).
16. Your act will be pulled behind a boat that fits the flow of the show, not by your boat preference.

*Team activities include: shows, tournaments, practices, any Team meeting, fundraisers, socials and special events.

If rules are violated ...

A written, documented and signed, allegation shall be presented before the Board of Directors. The Board shall vote to determine the consequence. The Board by majority vote may determine the next course of action. The Board is given full and final authority to select the best course of action. Suspension, if approved, may be full or partial, and for a limited period or until termination of membership process is completed. A suspended member may not vote or participate in activities as determined by the Board, but is still responsible for all money owed. Termination of membership must follow due process and be approved by 2/3 of the Board. Termination removes all privileges, rights and affiliations with the Central Wisconsin Water Ski Show Team. It does not remove the obligation to pay money owed. All individuals and families must apply for membership consideration on an annual basis. Previous actions and conduct may be criteria for non-approval by the Membership Committee.

AGREEMENT TO RULES AND REGULATIONS
